Drivers will be checked for alcoholic use

Line-up Begins at ~~9:00~~ 9:00 a. m. (please do not line up before this time)

Please enter parade line area from Delhomme or Appollo

Every float should have significant amount of throws for the entire parade route

Each float will be checked for, Proper Insurance Coverage and Fire Extinguishers

Registration Numbers Must Be Posted

(Small numbers on windshield – Large numbers back of float)

Floats should be ready to go when entering the parade line up.

No vehicles will be allowed into the line-up area.

All decorations should be on floats prior to line-up.

ALL BEADS and other items need to be on float before arriving at line-up.

All floats should be in line by *12:00 p.m.* Parade gates will closes promptly at *12:00 p.m.* Be On Time.

For safety reasons we asked, STOP throwing, when the parade stops.

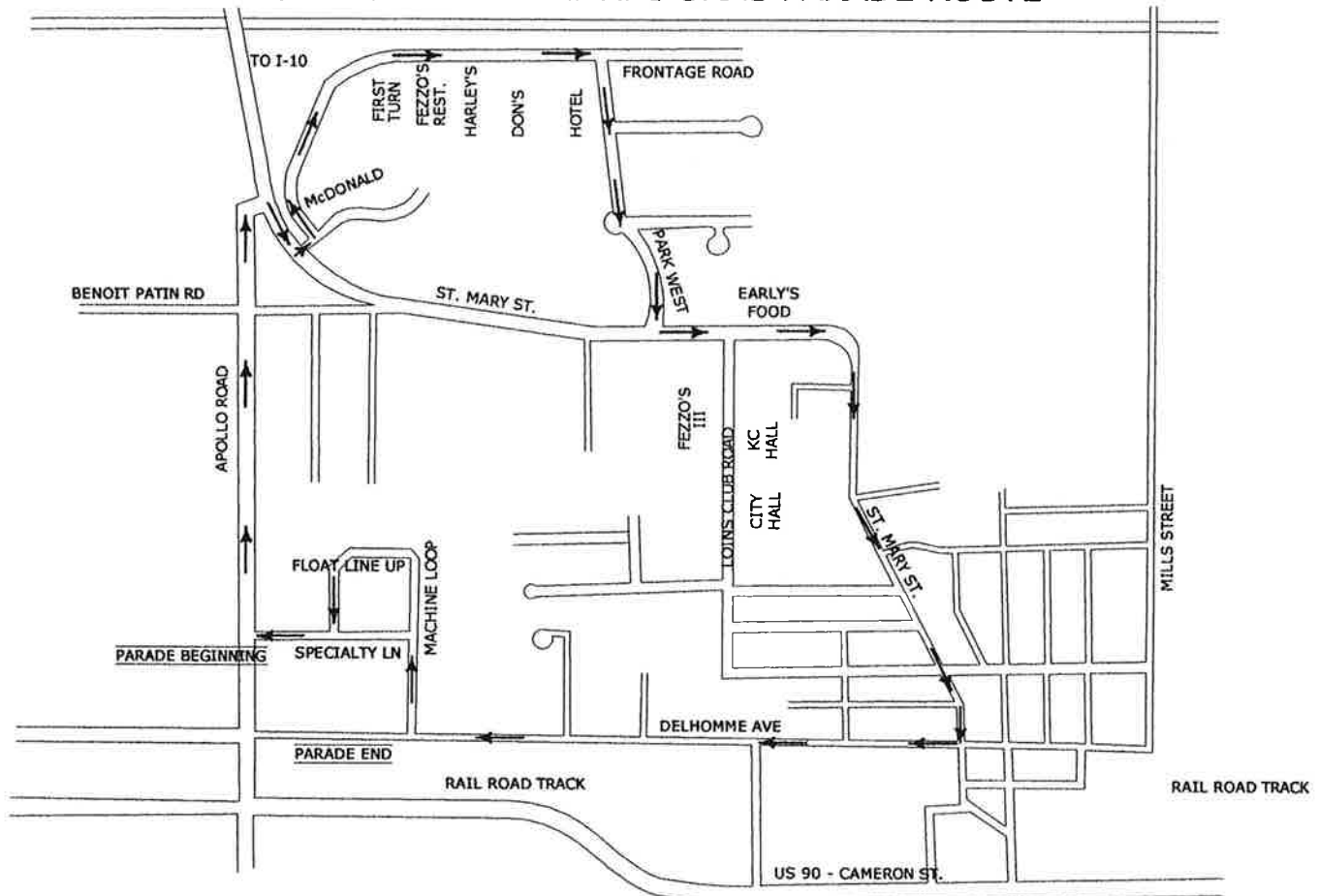
Crowds tend to get closer to floats creating a safety concerns.

CITY OF SCOTT MARDI GRAS PARADE ROUTE



THE FOLLOWING RULES WILL BE ENFORCED:

- * IF YOU HAVE YOUNG CHILDREN IN A GROUP, PLEASE HAVE WALKERS.
- * FLOATS MUST BE FOUR-SIDED.
NOT UNDER 3 FEET TALL AND MUST BE SOLID WALL MADE OF WOOD OR HARD SUBSTANCE.
- * FLOATS MUST BE LOADED BEFORE ARRIVAL. ONCE YOUR FLOAT IS IN THE LINE-UP, NO ONE WILL BE ALLOWED TO HAVE OTHER VEHICLES COME IN TO BRING THINGS ON THE FLOAT.
- * CHILDREN MUST REMAIN IN THE FLOAT (NOT HANGING OUT).
- * FOR THE SAFETY OF ALL - FLOAT DRIVERS - DRINKING & DRIVING WILL NOT BE ALLOWED FOR THE PARADE. LOCAL POLICE WILL ENFORCE THIS STRICTLY.
- * NO MOTOR CYCLES PERMITTED.
- * NO FOUR WHEELERS PERMITTED.
- * NO HORSES PERMITTED.
- * ALL FLOATS MUST HAVE A BACK RAIL, A ROPE WILL NOT BE ACCEPTED.
- * ANY VIOLATIONS UPON ARRIVAL WILL BE REFUSED AND REFUND WILL NOT BE GIVEN.
- * NO GLASS CONTAINERS ALLOWED
- * NO ONE ALLOWED TO RIDE IN BED OF PICK UP TRUCK.
- * EACH FLOAT MUST HAVE A FIRE EXTINGUISHER.

ORDINANCE NO. 2006-5

AN ORDINANCE OF THE CITY OF SCOTT, LOUISIANA,
ESTABLISHING AND ADOPTING RULES AND REGULATIONS
FOR PARADES WITHIN THE CITY OF SCOTT, LOUISIANA

WHEREAS, the Mayor and City Council of the City of Scott, Louisiana, in regular session assembled, did consider the merits of the hereinafter proposed action;

BE IT ORDAINED by the Mayor and City Council of the City of Scott, Louisiana, in regular session assembled, that the following ordinance is hereby adopted within the corporate limits of the City of Scott, Louisiana, to-wit:

SECTION I - PERMIT REQUIRED

A. Any procession, march, parade or trail ride of any kind or for whatever purpose by any group, association or organization, on any public sidewalk, street, highway, bridge, alley, road or other public passageway of the City of Scott, is hereby prohibited unless there first has been obtained a permit therefor, and in all cases the group, association or organization to whom the permit is issued shall be liable for all damage to property or persons which may arise out of or in connection with any such procession, march, parade or trail ride for which the permit is issued. Additionally, the group, association or organization applying for said permit shall provide a certificate of general liability and automobile liability insurance, insuring against any damage to property or persons which may arise out of or in connection with any such procession, march, parade or trail ride, said general liability and automobile liability insurances each to contain limits not less than \$100,000.00 per person and \$300,000.00 for each occurrence with respect to bodily injury or death, and \$100,000.00 for each occurrence with respect to property damage. Automobile liability insurance shall not be required for trail rides unless a vehicle participates in the trail ride.

B. Application for the permit required herein shall be made to and issued by the Mayor, or his/her designated representative.

SECTION II - RULES AND REGULATIONS FOR PARADES

Any parade of any kind or for whatever purpose shall comply with the following rules and regulations:

- A. Floats may not exceed forty (40) feet in length or ten (10) feet in width, and may not be less than three (3) feet or more than thirteen (13) feet in height. Floats must have four (4) solid sides constructed of wood or other hard substance;
- B. The following items are not to be thrown, handed or in any way delivered from any vehicle or float, or sold from any cart, to-wit: drug-related items, including, but, not limited to, items depicting drugs or drug use, sexually oriented items, animals (dead or alive), any items weighing over five (5) ounces, glass containers, or any pointed object. No music of a vulgar or sexual nature may be played on any float. Riders on floats shall not toss "throws" to the rear or front of their float;

- C. Each vehicle or float must display the name of the organization, business or individual it is representing;
- D. Each float must be equipped with at least one (1) fire extinguisher in good working order and a ladder or steps for entering and exiting the float. A float may not contain open flames, such as in bar-b-que pits, etc., or glass containers. No person may ride on the roof of any vehicle in the parade, or enter or exit a float during the parade;
- E. No float or vehicle with more than eighteen (18) tires shall be allowed, and with the exception of trail rides, no horses are to participate in any manner in a parade. Unless specifically allowed by the written policy of the parade permit holder, motorcycles and four wheeler vehicles may not participate in any manner in the parade;
- F. There must be one (1) adult supervisor (age 18 or older) for every six (6) children under the age of twelve (12) who are participating in the parade; and
- G. It shall be unlawful for any person to sell or possess any "silly string", as hereinafter defined, within three hundred (300) feet of any parade route within the City of Scott on any day a parade is scheduled. For purposes hereof, "silly string" is defined as any chemical product which, upon activation, emits a string-like substance by means of a propellant.

SECTION III. - PENALTY

Any person violating any provision of this ordinance shall be fined not more than THREE HUNDRED AND 00/100 DOLLARS (\$300.00) or may be imprisoned for not more than 30 days, or both.

SECTION IV. - EFFECTIVE DATE

This ordinance shall become effective immediately upon its adoption.

SECTION V. - REPEAL OF CONFLICTING ORDINANCES

Ordinance numbers 1999-5 and 2001-10 are hereby repealed. All ordinances or parts of ordinances in direct conflict herewith are hereby repealed.
