MINUTES OF REGULAR MEETING HELD AT SCOTT CITY HALL THURSDAY, JANUARY 6, 2022 AT 6:00 PM

The Mayor and City Council Members met in Regular Session, Thursday, January 6, 2022, All other Councilmen were present.

Councilman Hollier led the Prayer and Pledge.

Councilman Boudreaux motioned to accept the minutes from the December 2, 2021 meeting as written. Seconded by Councilman Montoucet, motion approved.

Councilman Montoucet motioned to accept the November 2021 Financial Statement. Seconded by Councilman Hollier.

The Mayor's Report consisted of reporting the Street Sweeper that was budgeted in FY 2022 has been delivered. Mayor Richard stated that a route is made so that roadways will be swept on a regular basis. Stay tune for a complete recap of the progress Scott has made next month, the "State of Scott" will be at the next Council meeting.

Mr. Mark Savoy with Groom's Engineering and Mrs. Jeanne Hornsby gave a brief update on on-going projects.

Councilman Boudreaux motioned to adopt Ordinance 2021-18, an Ordinance amending Sec. 31-2 and Sec. 31-6 of the Scott Municipal Code. After a long discussion, with property owners Mr. Thomas Huffman, Mr. Bobby Short, and Mr. John Trahan that spoke against the adopt the ordinance the Councilmen voted to adopt the Ordinance 2021-18. Seconded by Councilman Hollier, motion carried unanimously.

Mr. Thomas Huffman, property owner of 4702 Cameron St. requested a variance to Ordinance 2021-18, Sec. 31-2 (Fences). Mr. Huffman asked the council permission not to put up a required fence in front of his towing yard. After lack of motion, the request for variance died.

Councilman motioned to adopt Resolution 2022-1, A Resolution certifying to the Lafayette Metropolitan Planning Organization (MPO) that there is community support for the Apollo Road Widening Project from US 90 (Cameron Street) to Old Spanish Trail, and that the City of Scott commits to provide funding for the required match if the project is selected by the Acadiana Metropolitan Planning Organization for the Surface Transportation Program. Seconded by Councilman Montoucet, motion carried unanimously.

Councilman Suire motioned to adopt Resolution 2022-2, a Resolution authorizing the mayor to execute a servitude agreement between the Lafayette City -Parish Consolidated Government and the City of Scott. This Resolution would be to add a detention pond on the corner of Blanche and Ave A near the entrance to Scott Park. Seconded by Councilman Boudreaux, motion carried unanimously.

Councilman Suire motioned to approve a request for variance, Section 31-22 (b) residential fences at 300 Debonanaire Road (Percy & Stacy Frank). Councilman

Montoucet stated that the resident requested to add on to a fence using the same material. Seconded by Councilman Hollier, motion carried unanimously.

Mayor Richard asked the council for direction and discussion pertaining to the garbage contract which expires on June 30, 2022 and whether or not they would like to request proposals or a bid process. No decision was made and tabled until the next council meeting scheduled for February 3, 2022 at 6pm.

There being no further business, meeting adjourned at 7:15 pm.
