

**MINUTES OF REGULAR MEETING
HELD AT SCOTT CITY HALL
THURSDAY, November 6, 2025, AT 6:00 PM**

The Mayor and City Council Members met in Regular Session, Thursday, November 6, 2025. Mayor Richard, all council members were present.

Councilman Domingue led the Prayer and Pledge.

Councilman Roy motioned to accept the minutes from the October 2, 2025, meeting as written. Seconded by Councilman Montoucet, motion approved unanimously.

Councilman Boudreaux motioned to accept the September 2025, Financial Statement. Seconded by Councilman Domingue. Motion carried unanimously.

Mayor Richard announced several community events scheduled in the upcoming month such as "Made in Scott" Envision event, Scott Mardi Gras Parade, Christmas in Scott, and the Veterans Memorial Program. Please see a complete list on the city website with dates and times.

Chief Chad Sonnier presented firefighters a life saving award for a job well done.

Mayor Richard recognized Avery Trahan, the Scott Middle School Student of the Year.

Councilman Montoucet motioned to adopt Ordinance 2025-10, An Ordinance annexing the property owned by the Lafayette Parish School System located adjacent to Acadiana High School. No discussion. Seconded by Councilman Domingue motion carried unanimously.

Lafayette Parish Councilman for District 2, Mr. Donald Richard gave a district update and asked for support to pass millage renewal on the November 15th, 2025.

Councilman Boudreaux motioned to appoint Ms. Dawn Benoit to the Lafayette Parish Waterworks District North Board of Commissioners. Mayor Richard explained that the new appointment came because Mr. John Terry Fabre passed away. Ms. Benoit would fill is seat for the remainder of the term. Councilman Roy second the motion, carried unanimously.

Councilman Domingue introduced Ordinance 2025-11, an Ordinance to create General, Sec. 14, Article IX. Landscaping maintenance on commercial and retail property of the Scott Municipal Code. Ordinance 2025-11 will be up for adoption at the next regular council meeting scheduled for December 4, 2025, at 6pm.

Councilman Moreau introduced Ordinance 2025-12, an Ordinance amending Appendix C of the Scott Municipal Code to revise, enact and adopt fines and penalties for traffic and misdemeanor violations committed within the corporate limit of the City of Scott. Ordinance 2025-12 will be up for adoption at the next regular council meeting scheduled for December 4, 2025, at 6pm.

Councilman Montoucet motioned to adopt Ordinance 2025-13, an Ordinance amending the Scott Municipal Code to amend Chapter 30 Article III-Parades. Mayor Richard explained the main change would be limiting the max number of floats to eighty and allowing strictly just floats. There were no comments from the council or members of the audience. Ordinance 2025-13 will be up for adoption at the next regular council meeting scheduled for December 4, 2025, at 6pm.

Councilman Boudreaux motioned to adopt Resolution 2025-27, A Resolution authorizing the mayor to enter into an agreement to extend the contract between the City of Scott and Pelican Waste & Debris, LLC for one (4) year term. Seconded by Councilman Montoucet motioned carried unanimously.

Councilman Moreau motioned to adopt Resolution 2025-28, A Resolution authorizing the mayor to negotiate and execute a contract with C.H. Fenstermaker & Associates for architectural & engineering professional services for the Mills Street detention pond (LWI Round II, CDBG-MIT). The City of Scott received \$2.8 million in grant funding to construct a retention pond north of I-10 to assist in drainage and flooding. Seconded by Councilman Montoucet, motion carried unanimously.

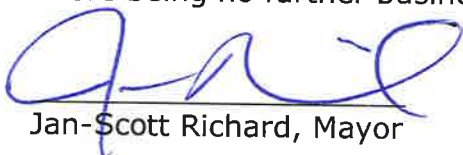
Councilman Domingue motioned to adopt Resolution 2025-29, A Resolution authorizing the mayor to negotiate and execute a contract with C.H. Fenstermaker, LLC for professional engineering and ancillary services for Delhomme Avenue bridge replacement and overlay project. No discussion. Seconded by Councilman Roy, motion carried unanimously.

Councilman Montoucet motioned to adopt Resolution 2025-30, A Resolution requesting financial assistance from the State of Louisiana under the fiscal year 2025-2026 Local Government Assistance Program and Community Water Enrichment Fund Program. Seconded by Councilman Boudreaux, motion carried unanimously.

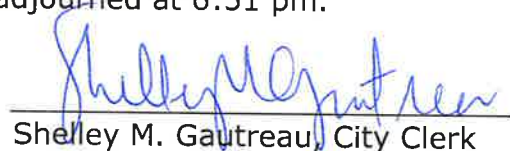
Councilman Roy motioned to amend the budget for \$15,000 for landscaping project which includes a monthly maintenance plan. Seconded by Councilman Roy, motion carried unanimously.

Councilman Montoucet motioned to grant variance to Louisiana Zippit LLC located at 2730 W. Willow Street to crush, sell, and remove existing rock and material on the property. Councilman Domingue motioned to second with the contingency to clean up property within ninety days from the meeting date. Motion carried unanimously.

There being no further business, the meeting was adjourned at 6:51 pm.
