

**MINUTES OF REGULAR MEETING
HELD AT SCOTT CITY HALL
THURSDAY, June 2, 2022 AT 6:00 PM**

The Mayor and City Council Members met in Regular Session, Thursday, June 6, 2022 at 6:00pm, Councilman Boudreaux was absent.

Councilman Hollier led the Prayer and Pledge.

Councilman Montoucet motioned to accept the Regular Minutes of May 5, 2022 as written. Seconded by Councilman Suire, motion carried by majority.

Councilman Hollier motioned to accept the Financial Statement of April 2022 as written. Seconded by Councilman Suire, motion carried by majority.

Mayor Richard reported on the following;

- Scott Park Update
- Sewer Smoke Testing to begin on May 31 in the downtown parts of Scott.
- Comprehensive Plan Charette-July 12-13, 2022
- June 8, 2022 at 6pm-Apollo Rd. Roundabout Discussion

Mr. Mark Savoy with Groom's Engineering and Mrs. Callie Benton gave a brief update on on-going projects.

Mayor Richard presented a Proclamation declaring June 2, 2022 "Maddie's Footprints Day."

Mr. Danny Gillane, Director of the Lafayette Public Library Director thanked everyone for their support in renewing the dedicated tax dollars as well as a list of new programs and events taking place over the summer.

Councilman Terry Montoucet announced that he will be running again as a Councilman candidate for the Scott City Council District 2 in the upcoming November 8th, 2022 election.

Councilman Bergeron motioned to adopt Ordinance 2022-4, an Ordinance amending the City of Scott Land Use map. The property is located at 450 Fieldspan Rd owned by KEO Properties LLC/Kevin Foret. The property will go from Industrial to T2 on the land use map. This change was approved by the Planning Commission. Seconded by Councilman Montoucet, motion carried by majority.

Councilman Bergeron motioned to adopt Resolution 2022-9, A Resolution authorizing the mayor to execute a contract for solid waste services between the City of Scott and Pelican Waste & Debris, LLC. No discussion. The new contract will begin on July 1st, 2022. Seconded by Councilman Hollier, motion carried by majority.

Councilman Hollier motioned to adopt Resolution 2022-10, A Resolution authorizing the sales of a 2010 Ford Crown Victoria, 2014 Chevrolet Tahoe, and a 2014 Chevrolet Tahoe to the City of Rayne. Seconded by Councilman Hollier, carried by majority.

Councilman Hollier motioned to adopt Resolution 2022-11, A Resolution authorizing the mayor to execute right of way instrument between the City of Scott and Entergy Louisiana, LLC. Entergy will be making improvements along Rue Bon Secours. Seconded by Councilman Suire, motion carried by majority.

Councilman Suire introduced Ordinance 2022-5, An Ordinance enlarging the boundaries of the City of Scott, Louisiana (Jenkins Road-KEO Properties LLC Area Annexation.) Ordinance 2022-5 will be up for adoption at the next regular Council Meeting scheduled for July 7, 2022 at 6pm.

Councilman Suire introduced Ordinance 2022-6, An Ordinance enlarging the boundaries of the City of Scott, Louisiana (Tabb Road-Foret Family Area Annexation) Ordinance 2022-6 will be up for adoption at the next regular Council Meeting scheduled for July 7, 2022 at 6pm.

Councilman Bergeron motioned to adopt the Official Municipal Journal as The Daily Advertiser. No discussion or questions. Seconded by Councilman Suire motion carried by majority.

Councilman Bergeron motioned to approve the Code exception approval for Superior Service Auto Tool, LLC located at 4720 Cameron Street. The Planning Commission approved the code exception. Seconded by Councilman Hollier, motion carried by majority.

Councilman Hollier motioned to grant a waiver for The Waters Apartments in the Estates at West Village. Mrs. Callie Benton, Engineer with Fenstermaker & Associates explained that the Apollo Rd. Ext was built higher to serve as an evacuation route. No questions or concerns from the Council. Seconded by Councilman Suire, motion carried by majority.

Councilman Bergeron motioned to move forward with working on a scope and projected cost for a sidewalk on Dulles Drive to help with the littering, trespassing, and pedestrians in the line of traffic. After a lengthy discussion from Mr. Jerry carpenter, a concerned citizen the motion was seconded by Councilman Suire passed by majority.

There being no further business, meeting adjourned at 7:00 pm.
