

**MINUTES OF REGULAR MEETING  
HELD AT SCOTT CITY HALL  
THURSDAY, May 2, 2019 AT 6:00 PM**

The Mayor and City Council Members met in Regular Session, Thursday, May 2, 2019 at 6:00pm, all Councilmen were present.

Councilman Bergeron led the Prayer and Pledge.

Councilman Montoucet motioned to accept the Regular Minutes of April 4, 2019 as written. Seconded by Councilman Hollier, motion carried by majority.

Councilman Bergeron motioned to accept the Financial Statement of March 2019 as written. Seconded by Councilman Montoucet, motion carried by majority.

The Mayor reported that the Grand Opening of the West Regional Library would be May 13<sup>th</sup> at noon and invited everyone to a Public Charrette to be held at City Hall on May 13<sup>th</sup> at 6pm. The purpose of the Charrette will be to gather opinions and ideas of what residents want to see in the West Village development. He also reminded the public that the Conservation Water Schedule is now posted.

Chief Chad Sonnier thanked the Red Cross for coming into our corporate limits to promote the Smoke Detector Installation Program. The team of volunteers successfully installed 212 smoke detectors in Districts 1 and 2.

Engineer's Report consisted of Mr. Mark Savoy with Groom's Engineering stated that the Destination Pointe detention pond is now functional. He also announced that a grant of \$849,000 for a sewer extension project on West Willow has been awarded to the City. Mrs. Jeanne Hornsby with Fenstermaker & Assoc. reported that Apollo Road Phase I will be complete weather permitting in May 2020. Mrs. Hornsby stated that they are working on securing funding from State Capital Outlay for the Apollo Road Roundabout at Dulles. Mrs. Hornsby is also working on a wide variety of city projects for necessary improvement, drainage being top priority.

Councilman Bergeron motioned to adopt Ordinance 2019-7, an ordinance amending the Scott Municipal Code to adopt and reenact Article VI Construction site storm water runoff regulations of Chapter 14 Environment. Mr. William Babin, City Attorney added that the permit fee would change to \$200. Seconded by Councilman Hollier, motion carried unanimously.

Councilman Boudreaux motioned to re-appoint Mr. Kirk Prejean to the Scott Planning Commission for a 5-year term beginning July 17, 2019. Mr. Pat Logan, Comprehensive Plan Facilitator made the recommendation. Councilman Montoucet seconded the motion, carried unanimously.

Councilman Montoucet introduced Ordinance #2019-8; an ordinance amending Sec. 16-7 of the Scott Municipal Code. The ordinance prohibits the obstruction of fire hydrants making sure accessibility at all times. The ordinance will be up for adoption at the next regular Council Meeting June 6, 2019 at 6pm.

Resolution 2019-15, a resolution authorizing the Mayor to execute an automatic aid agreement by and between the City of Lafayette and the City of Scott for fire protection services was adopted by the motion of Councilman Boudreaux seconded by Councilman Bergeron, motioned was carried unanimously.

Councilman Montoucet motioned to deny the appeal by Jaipsy Contracting, LLC from previous denial by the Planning Commission for use of property located at 408 Debonnaire Road for automotive mechanic shop. Mrs. Eddy Rodriguez, property owner was not present. Seconded by Councilman Hollier, motion carried unanimously.


Councilman Suire motioned to adopt Resolution 2019-16, a Resolution of the City of Scott providing for canvassing the returns and declaring the results of the special election held in the City of Scott, Parish of Lafayette, State of Louisiana, on March 30, 2019 to levy a new sales tax and dedicate the revenues derived from that special tax therein. Seconded by Councilman Hollier motioned carried unanimously.

Councilman Boudreaux announced that at the next council meeting, on June 6, 2019 at 6:00pm to be held at City Hall, the Scott Council may consider tax propositions for the upcoming October 2019 election.

A motion was made by Councilman Hollier to adopt Resolution 2019-17, a Resolution authorizing the Mayor to execute an intergovernmental agreement between the Lafayette City-Parish Consolidated Government and the City of Scott concerning assistance with various minor maintenance items. No discussion. Seconded by Councilman Bergeron, motion carried unanimously.

End of meeting public comments were made by Chief Sonnier inviting the Council to a PPE experience on May 23<sup>rd</sup>, 2019 at 6:30pm. As well as resident Mr. Donald Hargrave expressed concerns of barricades being moved during flooding events causing more problems for homeowners.

There being no further business, meeting adjourned at 7:00 pm.
