## MINUTES OF REGULAR MEETING HELD AT SCOTT CITY HALL THURSDAY, July 1, 2021 AT 6:00 PM

The Mayor and City Council Members met in Regular Session, Thursday, July 1, 2021. Councilman Montoucet was absent, and all other Councilmen were present.

Councilman Hollier led the Prayer and Pledge.

Councilman Boudreaux motioned to accept the minutes from the June 3, 2021 meeting as written. Seconded by Councilman Hollier, motion approved.

Councilman Boudreaux motioned to accept the Special Meeting minutes from the June 10, 2021 meeting as written. Seconded by Councilman Hollier, motion approved.

Councilman Boudreaux motioned to accept the Special Meeting minutes from the June 23, 2021 meeting as written. Seconded by Councilman Bergeron, motion approved.

Councilman Boudreaux motioned to accept the May 2021 Financial Statement. Seconded by Councilman Suire, motion approved.

The Mayor's Report: Mayor Richard wished everyone a happy and safe 4<sup>th</sup> of July Holiday. Reminded the public about the "Back to School Bash"/ Park Dedication to be held on 7/10/21 from 10-1pm. For a detailed list please visit the Mayor's and/or City's Facebook page.

## Engineer's Reports:

Groom's Engineering received the comments from the Health Department for the Desjacque/ Westgate force main. The Ulinor Road Overlay being done by Lafayette Parish IGA should be complete by the next Council Meeting. Fenstermaker & Associates reported the clearing and grubbing is almost complete on Apollo Road Phase II & III, a video was also shown of the progress. The traffic study for the LA 93-I-10 to Renaud should be complete by September 2021. Surveying is underway for the St. Mary Street sidewalk project.

Councilman Boudreaux motioned to adopt Ordinance 2021-7, an ordinance amending Sec. 31-2 and Sec. 31-6 of the Scott Municipal Code which refers to commercial (towing yards) fencing requirements and enforcement. No discussion. Seconded by Councilman Suire, motion carried by majority.

Councilman Bergeron motioned to adopt Resolution 2021-20, A Resolution of the City of Scott adopting the Lafayette Parish-Wide Mitigation Plan 2021. No discussion. Seconded by Councilman Hollier, motion carried by majority.

Councilman Suire motioned to approve and give the Mayor authority to execute a contract with Home Bank to serve as the Fiscal agent for the time period 2021-2025. Seconded by Councilman Hollier, motioned carried by majority.

Councilman Hollier motioned to approve a code exception to allow use of the property located at 5400 A Cameron Street for a Bar- Bayou Blues. The building will be used for comedy shows, a bar, a rental venue, car shows, and art pop-up markets. Seconded by Councilman Suire, motioned carried by majority.

Councilman Boudreaux motioned to adopt Resolution 2021-21, a Resolution authorizing the mayor to execute a servitude agreement between MJM Associates LLC, and the City of Scott. Mr. Mark Savoy with Groom's Engineering explained that this agreement is needed to relocate the pump station on Lowell Road to increase sewer productivity. Seconded by Councilman Hollier, motion carried by majority.

Councilman Bergeron introduced Ordinance 2021-10, an Ordinance amending sec 24-56 and sec 24-58 of the Scott Municipal Code. No discussion. Ordinance 2021-10 will be up for adoption at the next regular council meeting scheduled for August 5, 2021 at 6pm.

Councilman Boudreaux motioned to adopt Resolution 2021-22, A Resolution granting the authority to the mayor to sign and submit all necessary documents along with adopting certain policies, plans, and procedures in connection with the FY 2021 Community Developing Block Grant Program for sewer system improvements project. Seconded by Councilman Suire, motion carried by majority.

Councilman Boudreaux motioned to adopt Resolution 2021-23, a Resolution authorizing the mayor to execute amendment No. 1 to intergovernmental agreement (IGA) between the Lafayette City-Parish Consolidated Government and the City of Scott concerning the operation and maintenance of the traffic signal at the intersection of Eraste Landry Road and Westgate Road. Seconded by Councilman Hollier motion carried by majority.

There being no further business, meeting adjourned at 7:00pm.
