The City of Scott offers a very important service to rental property owners. By completing a "Landlord Authorization To Revert Form" the City of Scott will automatically place your rental property utilities into your name when a tenant requests disconnection.

You will receive a separate billing for each property when the service is reverted to your name. We must rely on you to ensure the accuracy of the information you provide and keep it current. Please notify us if you sell any of the reverted properties, buy additional properties that need to be reverted or any other related information.

If you choose not to participate in this program, then the landlord would be required to put a deposit before services are turned back on. Also, please note that it is illegal to tamper or turn on water meters and will be prosecuted as a misdemeanor.
