MINUTES OF REGULAR MEETING HELD AT SCOTT CITY HALL THURSDAY, March 4, 2021 AT 6:00 PM

The Mayor and City Council Members met in Regular Session, Thursday, March 4, 2021, all Councilman were present. Councilman Hollier led the Prayer and Pledge.

Councilman Montoucet motioned to accept the minutes from the February 4, 2021 meeting as written. Seconded by Councilman Bergeron, motion approved.

Councilman Boudreaux motioned to accept the minutes from the Special Meeting of February 10, 2021 meeting as written. Seconded by Councilman Hollier, motion approved.

Councilman Boudreaux motioned to accept the January 2021 Financial Statement. Seconded by Councilman Montoucet.

Ms. Sarah Dake with Senator John Kennedy's office gave a brief update.

Mayor Richard reported that Monday, March 15th construction will begin on the Hwy 93 roundabout that should last 3-6 months. Also, the start of an economic development grant to bring broadband into the area as well as the launch of a Litter Incentive Program.

Mayor Richard presented the "State of Scott Address." To view go to the "LIVE" tab on the website.

Councilman Montoucet introduced Ordinance 2021-1, an ordinance of the City of Scott, Louisiana, granting unto Lafayette City-Parish Consolidated Government a non-exclusive franchise for the construction, maintenance and operation of poles, wires and appurtenances for electric transmission and distribution in the City of Scott, Louisiana. A lengthy discussion between Councilmembers and Franchise representatives took place. Ordinance 2021-1 will be up for adoption at the next regular council meeting scheduled on April 1, 2021 at 6 pm.

Councilman Hollier motioned to install four to five speed tables on Cheyenne Circle. The speed tables will be placed for six months then effectiveness will be reassessed. Several residents spoke about speeding and increased traffic issues. After a lengthy discussion, a motion was Seconded by Councilman Bergeron, carried unanimously.

Councilman Montoucet motioned the approval of Code Exception for use of property located at 249 Dejacques Road for an Automotive Mechanic Shop. No discussion. Seconded by Councilman Suire, motion carried unanimously.

Councilman Suire motioned to grant a variance to Noise Ordinance, section 14-27 Fright Trail, 5401 Cameron Street for the month of October 2021. Mr. Rich Hanf reported that there have been no issues in the past. Seconded by Councilman Montoucet, motion carried unanimously.

Councilman Bergeron motioned to rename line item 10-11-6301 Mardi Gras cleanup to roundabout beautification \$5,360.00 and rename Capitol item 21-75-7400-20 Provost Rd/Old Spanish Trail sidewalks to Highway 93 traffic study \$90,000. No discussion. Seconded by Councilman Boudreaux, carried unanimously.

Councilman Boudreaux motioned to adopt, Resolution 2021-8, a Resolution accepting that that certain act of dedication of utility servitudes, and water and sewer improvements, for West Village-Phase I. Mr. Mark Savoy, Groom's Engineering made a recommendation to accept knowing there would be a 1 year warranty with contractors. He was confident that the remaining ten items on the punch list would be taken care of. Seconded by Councilman Montoucet, motion carried unanimously.

Councilman Hollier motioned to adopt Resolution 2021-10, A Resolution authorizing the Mayor to execute an act of donation. Mr. William Babin, City Attorney corrected that the Resolution would be for the life station for Berchman Oaks, LLC. Seconded by Councilman Suire, motion carried unanimously.

Councilman Montoucet introduced Ordinance 2021-2, an ordinance amending Sec 9.03 of the City of Scott 1968 Sales and Use Tax Ordinance. Ordinance 2021-2 will be up for adoption at the next regular council meeting to be held on April 1, 2021 at 6 pm.

Councilman Suire introduced Ordinance 2021-3, an ordinance amending the City of Scott 1984 Sales and Use Tax Ordinance. Ordinance 2021-3 will be up for adoption at the next regular council meeting to be held on April 1, 2021 at 6 pm.

Councilman Bergeron introduced Ordinance 2021-4, an ordinance amending Sec 3 of Ordinance 2019-20 regarding the Sales and Use Tax levied by the Apollo-Destination Pointe Consolidated Economic Development District. Ordinance 2021-4 will be up for adoption at the next regular council meeting to be held on April 1, 2021 at 6 pm.

Councilman Boudreaux introduced Ordinance 2021-5, an ordinance enlarging the boundaries of the City of Scott, Louisiana (Provost Family/ Old Spanish Trail Area) Ordinance 2021-5 will be up for adoption at the next regular council meeting to be held on April 1, 2021 at 6 pm.

There being no further business, meeting adjourned at 8:45 pm.
